**Situation**

The properties are prominently situated immediately south of Junction 4 of the M3 Motorway, on the north side of the busy Hawley Lane (B3272), close to its junction with Farnborough Road (A325). The locality is an established and busy commercial area with occupiers including Bentalls Distribution Warehouse, Lock N Store and BEW Electrical Wholesalers.

**Description**

The properties comprise three newly refurbished, purpose built warehouses with a prominent frontage to Hawley Lane. Each unit consists of an open plan ground floor and first floor gallery, to provide flexible business space. These Industrial Units could be used for Trade Counter (subject to consent). Unit 7 appears to be in Trade Counter use. The units each benefit from a total eaves height of 8.8m (28' 10"), a vehicle access loading door, a private yard, unloading areas and private parking.
