The property, which is Grade II listed, comprises 396.40 sq m (4,268 sq ft) of office and residential accommodation arranged over the lower ground, ground and three upper floors. The property benefits from high ceilings & excellent natural light creating a bright & spacious environment.

The property offers potential for conversion to a single-family residence (Class C3), including the addition of a new basement excavation beneath pavement vaults, installation of plant and solar panels on the main roof, replacement of windows on both front and rear exteriors and the addition of two internal lifts, requiring only minor demolition. The property had planning permission in May 2014 for the development outlined above (14/04615/FULL), although this has now lapsed (<https://www.westminster.gov.uk>).
