## Situation

The property is located in Leith, a district to the north of the city of Edinburgh. The building is located on Manderston Street, off Leith Walk (A900), a busy thoroughfare which connects the city centre to the waterfront and docks. The area is in a predominantly residential and industrial area with a number of motor trade businesses operating from the same terrace. Other nearby occupiers on Leith Walk include Ladbrokes, William Hill, Cashino Gaming, Scotmid Co-operative, Pizza Hut, Subway and Greggs.

#### Description

The property comprises a substantial former theatre building. The property is currently used as a bingo hall providing a foyer area, gaming hall, storage and ancillary and office accommodation over basement, ground and two upper levels. The property benefits from a site area of approximately 0.295 hectares (0.73 acres).
