Situation

The property is situated on the south side of Wellheads Road, Dyce within the Farburn Industrial Estate at its junction with Burnside Drive. Aberdeen International Airport is in very close proximity as is The Event Complex Aberdeen (TECA) and P&J Live are also within half a mile. Surrounding occupiers include BP, Falck Safety and MB Systems.

Description

The comprises two separate but adjoining sites :-The West Site (Heritable) extends to approx. 1.60 acres (0.65 hectares) and comprises a detached office and workshop building with car parking and a secure yard area. The East Site (Leasehold) extends to approx. 1.52 acres (0.615 hectares) and comprises a detached workshop building of steel portal frame construction with a yard for external storage.

There is separate vehicle access to each site the West Site is accessed via Wellheads Road and the East Site from Burnside Drive.

Tenure

Part Heritable (West Site) and Part Long Leasehold (East Site) on a lease expiring in 2077. The current passing rent is £43,400 per annum (plus VAT) with ground rent reviews on a five yearly basis.
